### Rules For Use Of Parks & Pavilions

**Revised 8/16/18**

1. A Pavilion Rental Contract is required for anyone using a pavilion in one of the City parks. A **Pavilion Rental Contract must be in hand** for validation.
2. Groups, organizations, and individuals using the parks and/or facilities will **comply with the laws** of the State of Alabama, the City of Alabaster, and the Alabaster Parks and Recreation Department.
3. **Alcoholic beverages are not allowed** in any park for any organization and/or applicant.
4. All activities shall be properly controlled and supervised. Whenever persons participating in the planned activity are under 17 years of age, adequate **adult supervision** must be provided.
5. **No loud or excessive noises** will take place that will disturb other users of the park or park neighbors.
6. The Director of Parks and Recreation, other authorized personnel, or the City of Alabaster Police have the right to **revoke a contract** at any time if they deem necessary.
7. **No person shall** solicit contributions, nor offer to sell or exchange any article or thing, nor buy or offer to buy any article or thing, for any purpose whatsoever, within any of the parks of the City, except by permission of the Parks & Recreation Director.
8. Permit holder is required to provide their **own trash bags** for their event. All trash and litter (resulting from the event) is to be bagged up, and placed in trash receptacles. Any overflow should be placed in the nearest dumpster.
9. No person shall park any **motor vehicle** in any of the parks of the City except in areas specifically designated for the parking of such vehicles. Vehicles are not allowed on the walking tracks/trails. Driving or parking on grass is prohibited in all City parks.
10. The applicant agrees to assume liability for any **damage** done to any City property.

11. **The City of Alabaster will not be liable** for any claims for injury or damages resulting from or arising out of the use of the City's facility or premises and the contract holder agrees to indemnify the City and hold it harmless against any and all such claims, damages, losses and expenses. If requested by the City, the contract holder shall carry insurance against such claims and furnish the City with a certificate of insurance evidencing same.
12. **No tents or canopies are allowed** (due to potential damage to underground utilities) in any of the parks unless prior written approval from the Parks and Recreation Department has been obtained.
13. **No inflatable** (such as space bounce, moon walk, etc.) is allowed in any of the parks.
14. **Charcoal grills are strictly prohibited** from being brought into any City park as dumped coals can be a fire hazard.
15. **Gas and propane grills are allowed** in the parks. However, you are required to place aluminum foil on the ground or floor beneath the grill to catch the drippings.
16. **Picnic tables** are not allowed to be moved from one pavilion to another.
17. **You may not affix anything** to the pavilions including staples, tape, push pins, tacks, string, ribbon, balloons, glue, etc.
18. The use of **confetti is strictly prohibited** in any of the parks.
19. The use of **piñatas is strictly prohibited** in any of the parks.
20. **Chalk is prohibited** from being used on the concrete floors of the pavilions.
21. **Pony rides are prohibited** in all City parks unless it is a City sponsored event.
22. **Pets are allowed** in City parks only if they are on a leash. Pets are **not allowed** past the entrance gates of any athletic facilities within Alabaster City parks.
